❖ **Replace content under *High School Diplomas/Transcripts* on page 11 with below:**

High School Diplomas/Transcripts

The Department of Education and our accreditation agency require IIC to evaluate all high school diplomas or transcripts. All high school diplomas and/or transcripts are required to have a valid post-secondary school name and must not be in any fashion a “diploma mill”, a date of graduation, and may need a signature from a principal or superintendent. If the Admissions department is given a high school diploma that it or the Department of Education deems to be questionable, the student will be asked to provide more information or may be denied acceptance to school. This information must include at least one of the following: a) Transcripts; b) Written descriptions of course requirements; or c) Written and signed statements by principals or executive officers at the high school attesting to the rigor and quality of coursework at the high school. If the student has a high school diploma or transcript from a foreign country, it is the student’s responsibility to have it translated and be evaluated as an equivalent to a U.S. high school diploma, if applicable.
